One-stop support for start-ups venturing into the Korean market

- ACE signed MoUs with KiSED, KBAA and SBA to promote bilateral cooperation in supporting and developing the startup ecosystems, and foster global enterprise between Singapore and Korea.
- The parties will establish strategic collaboration to promote a vibrant connected start-up ecosystem and support each other in the identification and recommendation of potential start-ups with the interest to venture into the Singapore or Korean market.
- Start-ups will be able to receive reciprocal support such as access to knowledge sharing workshops, localisation programmes, support clinics and connection facilitation to network, market access advice, and investment opportunities, amongst others.
- The strengthened collaborations translate into a one-stop comprehensive support for local start-ups looking to venture into Korea or Korea start-ups looking to set up their businesses in Singapore.

Singapore, 14 November 2017 – The Action Community for Entrepreneurship (ACE), a national private-led organisation with the mission to drive innovation and entrepreneurship in Singapore, has recently signed а Memorandum of Understanding (MoU) with Korea Institute of Start-up and Entrepreneurship Development (KiSED), Korean Business Angels Association (KBAA) and Seoul Business Agency (SBA) with support from International Enterprise (IE) Singapore. The objectives of the MoUs aim to promote cooperation in supporting and developing the start-up ecosystems, and foster global enterprise between Singapore and Korea. For Singapore based start-ups, this would mean that they are now able to navigate the Korean market with ease and receive onestop support in their overseas expansion efforts.

Following the success of the ACE-Fukuoka City collaboration to promote Japan-Singapore bilateral technological and economic developments, the current MoUs provides three additional partners which Singapore start-ups can tap on to

help start-ups expand their business through the ACE International Centre (ACEIC). As part of the Government's efforts to boost Singapore's start-up scene under the Start-up SG brand, the ACEICwas launched on 6 September 2017 by Senior Minister of State for Trade and Industry, Dr Koh Poh Koon, as a dedicated one-stop centre to support start-ups in international growth and expansion.

Through the MoUs, the various organisations will support one another in the identification and recommendation of potential start-ups with the interest to venture into the Singapore or Korea market. Start-ups will receive reciprocal privilege access and comprehensive supports to knowledge sharing resources, business consultation, networking and funding opportunities, and market access assistance, amongst others.

Prior to the signing of the MoUs, the ACEIC has already started working closely with start-ups in Korea and provide assistance to help them land into the Singapore market. In September this year, the ACEIC has welcomed its first batch of five Korean start-ups attending a local market acceleration programme hosted at the centre. While in Singapore, the start-ups were able to gain valuable insights to the Singapore ecosystem, received support in business consultation and mentorship. Further to that, the ACEIC has also attracted three Singapore start-ups that will be venturing into the Korean market through the ACE-KISED joint Market Access Programme this year.

The Korea start-up market is a thriving market in terms of market vibrancy and diversity of offerings from e-commerce, food delivery to online/offline cosmetics products. Since the introduction of the Creative Economy initiatives by the Korea Government that welcome and drive the growth of start-ups in Korea, the Korea start-up scene has reflected significant growth. From 2015 to 2016, there is a reported 49% YoY growth in number of start-up investments and 23% increase in investment size (811.96 Billion KRW in 2015, 1007.8 Billion KRW in 2016)¹. The Creative Economy has also brought with it multiple co-working spaces, incubators and acceleration programmes.
